## Group 3 - Associate Level:

The Associate Level allows any company providing services to the ready mixed concrete industry to participate in the on-going CPCNC efforts to create demand for the products of our industry. Annual investment is \$500.

Group 3: Associate Members\*\* = \$500/Yr

\*\*Associate members include: contractors, developers, trucking companies, engineers, municipalities and any other organization interested in the promotion of and education about sustainable ready mixed concrete applications.
